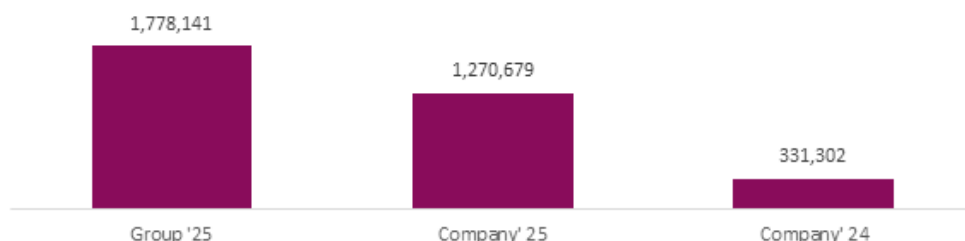

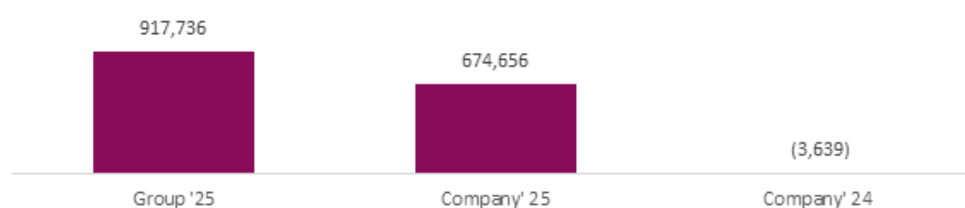

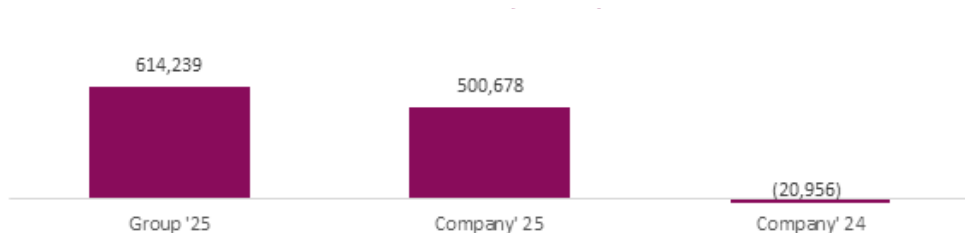
Revenue (N'000)
